About the Contributors

Jay Barth is M.E. and Ima Graves Peace Emeritus Professor of Politics at Hendrix College. Barth's academic work includes research on the politics of the South, state government and politics, LGBT politics, political communication (particularly radio advertising), and the achievement gap in Arkansas. He is the co-author (with the late Diane D. Blair) of the second edition of *Arkansas Politics and Government: Do the People Rule?* (University of Nebraska Press, 2005).

Craig M. Burnett is Associate Professor of Political Science at Hofstra University. Burnett's research focuses on direct democracy, urban politics, survey research methods, and electoral systems. His previous research has appeared in several academic journals, including the *Journal of Politics*, *Political Communication*, *Political Behavior*, and the *Minnesota Law Review*. Burnett's research on ranked-choice voting has also been covered by leading news organizations, including *The New York Times* and *The Wall Street Journal*.

Ty Dooley is an Associate Professor at the University of Illinois Springfield. He holds a Ph.D. in Public Policy from the University of Arkansas, a Master's Degree in Political Science from the University of Memphis, and he received his Bachelor's Degree from the University of Central Arkansas. Dr. Dooley's research areas include: social justice, critical race, social equity and community development. Previously, Dr. Dooley has served on the faculty at the University of Central Arkansas, the University of Memphis, and at the University of Texas at Dallas.

Jacob Holt is an assistant professor of political science at Columbus State University. His research focuses on legislative institutions. He has published articles examining preference outliers on legislative committees and interest group spending in US House elections. He was a 2018-2019 American Political Science Association Congressional Fellow working in Representative Denny Heck's office.

Joseph Yuichi Howard (Ph.D., University of Houston, 2006) is an Associate Professor of Political Science at the University of Central Arkansas in Conway, Arkansas. His primary area of research is in the field of public policy with a particular interest in policy implementation and education policy reforms. His current research efforts are focused on examining organizational commitment to educational reforms and the use of voluntary property taxes in Arkansas. His research has appeared in *Public*

Administration Review, Review of Policy Research, Public Performance and Management Review, and The Midsouth Political Science Review.

Heather M. Kopp is a PhD student in Political Science at the University of Missouri. Her research interests include international conflict processes of wars, disputes, and crises; violent non-state actors and transnational relations; and political methodology. She received her Bachelor of Science in Political Science and History at Truman State University in May 2019.

Janine A. Parry is Professor of Political Science at the University of Arkansas in Fayetteville. Her research and teaching focuses on state politics, voter behavior, and gender, politics, and policy. She is the co-author of *Women's Rights in the USA* (5th edition), co-editor of *Arkansas Politics and Government* (2nd edition), and has published research in *Political Behavior, Social Science Quarterly, State Politics and Policy Quarterly*, and other outlets.

Michael Rudy is an associate professor of Political Science and International Relations at Truman State University. Research interests including security studies, interstate conflict, and foreign policy decision-making.

Jaeyun Sung is an Associate Professor of Political Science at Lyon College, where she teaches courses in American Politics. Her research interests include campaign politics, electoral behavior, public opinion, political parties, and political communication. She received her PhD from the University of Georgia.

Gizachew Tiruneh holds a Ph. D. from the Binghamton University, New York, and is an associate professor of political science and the Director of the International Studies Program at the University of Central Arkansas. He teaches comparative politics and international relations courses including dynamics of democratization, globalization, African and Middle Eastern politics, and political methodology.
